West Midlands' libraries, museums and archives have been busy collecting stories for the BBC's People's War project over the last year. Supported by grants from Culture Online's regional fund and working in partnership with volunteer bureaux, Age Concerns, WRVS, veterans, local interest groups and IT trainers, 86 different events have taken place across the region since June and more are in the pipeline.

Events include drop-in sessions, speaker events and tea parties hosted in libraries, supported variously by volunteer bureaux, local record offices and museums. IT classes for older people are being held at Shrewsbury and Coventry Library and Hereford WRVS centre and trained volunteers from Age Concern and local bureaux have collected stories in day centres throughout Shropshire, Birmingham and Worcestershire.

The largest event funded by Culture Online so far was a lunch party thrown by Age Concern Birmingham for 90 day centre users from Ladywood and Handsworth. Stories poured forth about wartime life in England, France, the

North Atlantic, Ireland and Jamaica, stimulated by artefacts provided by Birmingham Museum & Art Gallery and Birmingham local studies library.

As we enter 2005, the 60<sup>th</sup> anniversary of the end of WW2, we must make every effort to capture the memories and stories of those who experienced such momentous times.

#### Veterans Reunited

In January 2004 the Big Lottery Fund launched its Veterans Reunited programme to provide funding to commemorate the 60<sup>th</sup> anniversary of the events leading up to the end of World War Two. The programme comprises three different schemes, which help ensure that all generations of UK residents can commemorate the anniversary together. The three schemes are:

Home Front Recall - veterans of WW2 are to take pride of place across the West Midlands at dramatic performances, reunions, photographic exhibitions and a variety of commemorative events to mark the 60<sup>th</sup> anniversary of the end of WW2. The £7.3 million Home Front Recall scheme is a joint initiative from the Big Lottery Fund and the Heritage Lottery Fund. Grants of between £500 and £20,000 are provided for regional and local projects that commemorate the events of the WW2.

Heroes Return – this £10 million scheme provides funding to WW2 veterans, their wives/husbands, widows/widowers and, where required, their present day carers, to visit the overseas areas where the veterans saw active service. Heroes Return is also helping to give young people a better understanding of the efforts and sacrifices made by veterans.

#### (Applications for both of these schemes must be submitted by 31 March 2005.)

Their Past Your Future – this is a UK wide schools and education scheme to give young people the opportunity to learn first-hand from veterans about their experience of war. The BLF is working closely with the Imperial War Museum and the museum, library and archive sector to help young ones research and learn about the roles played by forces personnel and civilians.

#### Museum Accreditation Scheme replaces Registration

One hundred and forty museums in the West Midlands region have been helped to improve their standards and raise their profile by identifying areas that need attention and encouraging further development.

Launched on 17 November 2004, the MLA Museum Accreditation Scheme gives clear, basic requirements for how museums should care for and document their collections, be governed and managed and on the information and services they should offer to their visitors. The Scheme replaces the previous Museum Registration Scheme and sets out 'foundation level' standards for museums across four key areas: Governance and Museum Management, User Services, Visitor Facilities and Collection Management. The Scheme builds on existing professional standards, which have been extensively revised and updated after a major consultation process, to reflect people's growing expectation of visitor attractions. It covers all museums, from major national institutions to the smallest, volunteer-run independent museums.

Museums will be invited to apply within the next 5 years and a county by county timetable for invitations has been organised.

#### The Designation Scheme opens to Libraries and Archives

The new extended Scheme, run by Museums, Libraries and Archives Council, will identify

#### library and archive collections in non-national institutions that are deemed of national or international importance.

Since 30 November 2004 libraries and archives can now join museums in this scheme and enjoy the following benefits reported by museums: a strengthened support from their governing bodies, enhanced ability to raise funds to support their collection, added national profile-raising through MLA Council's promotional materials, and the creation of a local focus for advocacy and awareness-raising. Chris Batt, MLA's Chief Executive, said: "Collections are the bedrock of our sector – they are the foundations upon which all of our work is based. I'm delighted that Designation is now a cross-domain scheme and encourage colleagues in libraries and archives to take this opportunity to highlight the collections in their care."

MLA are inviting applications from libraries and archives and joint applications from existing formal partnerships of organisations with complementary collections, which can demonstrate that their collection is of pre-eminent quality and significance.

From April 2003 the Assembly has been the Regional Planning Body for the West Midlands region, charged with producing and implementing the West Midlands Spatial Strategy, formerly Regional Planning Guidance (RPG 11).

This new document has many new references to the importance of the historic environment, making it significantly more important than in previous documents. This is a result of comments made during consultation by English Heritage, the National Trust, the Historic Environment Forum and others.

#### Museums & Galleries Month 2005 – Objects of Desire: The Art of Collecting

Museums and Galleries Month is a good opportunity for all to work together on a common theme to raise the profile of your organisations.

The theme for 2005, 'Objects of Desire' is inspiring many interpretations. New ideas for events linked to the theme and the Museums Association consultation on collecting have been developed. Why not explore some of these ideas with your colleagues?

**National events:** lectures and discussions on issues relating to collecting, for example, collecting intangible heritage; collecting contemporary culture and different cultures; link to the portable antiquities scheme – metal detecting. Or subject specialist networks.

**Exhibition and events:** individual collections, online collections with school children using 'Museum in the Classroom on the 24 Hour Museum; private collections and the private collector through history; an online 'swap shop' where museums can loan or swap objects; a House Doctor to clear out the stores; conservation – vote for the object to be restored; votes for today's most desirable objects that should be collected; celebrity choices of objects; or link with other events during 2005 through maritime collections and World War II memories.

#### Museums & Heritage Awards for Excellence 2005

The Restoration and Conservation Award is a new category for this years Awards. It will highlight the quality of work undertaken on restoration and conservation projects within the UK over the last year, and how projects have been managed and implemented. This can be the renovation of a single painting or the restoration on an entire historic house. The Awards will take place in London on 11 May 2005 to coincide with the opening of the Museums & Heritage Show.

The public vote will commence online and within pages of The Independent at the beginning of 2005, allowing members of the public to nominate their favourite attractions for an Award.

The **Award for Excellence Overseas** has also been further developed to included entries from companies working with a host of overseas contracts rather than just one single new build.

## Black Country Archives Prepare for Disaster

Two training days ensured that all the staff from the four Black Country Archive and Local History Services of Dudley, Sandwell, Walsall and Wolverhampton, knew how to react to potential fire or flood disasters. The first training day provided specialist facilities for the drying of books, documents, photos and artwork, specialist cleaning of mould contamination, secure freezer storage and learning of smoke and fire contamination.

Jon Everall and Ian Maver, conservators at Wolverhampton and Walsall, delivered the second training day. The staff heard best practice guidelines on storage, basic conservation and preservation issues. Dudley and Sandwell found this day extremely useful, as they do not currently have conservators of their own.

Funded under the Development Fund Grants Programme by MLA West Midlands the 'Keeping our Word' project enhanced all members of staff in their skills in taking care of the unique and irreplaceable collections in their care.

#### **Coventry Transport Museum wins Best** Attraction Award

Coventry Transport Museum was voted the top visitor attraction in Coventry and Warwickshire in the region's 'Godiva' Awards. The award was a 'People's Choice' with votes cast by a regional, national and international audience. The museum was re-launched on 18 March 2004 following a £7.5 million facelift and welcomed 180,000 visitors in the first 6 months alone.

New attractions include a gallery dedicated to cars, cycles and even skateboards, a hi-tech interactive 'Futures' gallery, an 'Introductory' gallery profiling Coventry's transport heritage, and a temporary gallery providing a stage for programmes of high profile exhibitions.

Before redevelopment the museum attracted on average 140,000 visitors a year. The museum is now on course to attract over a quarter of a million visitors a year. School visits account for an average of 17% of visitors, and educational visits or 10%, thus a total of some 30,000 pupils a year.

Developed by NIACE and 2wm this directory is intended to act as a signpost to learning resources in the region. #### **Disability Access Steering Group**

## Initial Teacher Training 'Literature Matter' Initiative for Libraries

The project arose out of research that indicated Initial Teacher Training students had a poor awareness of what libraries could offer their teaching across curriculum subjects and was therefore not utilising school and children's library services.

Funded by the Museums, Libraries and Archives Council, the Arts Council England and the Department for Education and Skills, the 'Literature Matters' initiative aims to:

enhance links between Initial Teacher Training providers, libraries and the literature sector; increase teacher trainee's knowledge of children's books and libraries (with particular reference to diversity)

increase teacher trainee's confidence in promoting children's books and in using libraries services.

MLA West Midlands has set up a working group with representatives from the Association of Senior Children's and Education Librarians, the Arts Council and the Teacher Training Association to look at how the initiative, which runs from January 2005 to September 2006, will be developed in this region. ## Brussels supports working plan for Culture

European Ministers of Culture are investigating the contribution of the cultural and audiovisual industry to European competitiveness. This investigation is one of the proposals from the State Secretary Van der Laan's new work plan for culture. Once the investigation has been completed, a report will follow in the European Council.

The EU sees the mobility of museological collections and artists as an effective means of bringing more Europeans into contact with heritage and culture.

The Council of Education, Youth and Culture approved an action plan for the digitalisation of heritage, to connect different initiatives of member states. The action plan will be ready in 2005. The European Council will also be presenting a new plan for a new web portal. It will promote the mobility of those who work in the culture sector, support museological collections and encourage intercultural dialogue.

#### The Success of the People's Network

A recent independent evaluation report, by the Tavistock Institute, shows that the People's Network has been effective in broadening the user base of libraries and repositioning them at the heart of local communities.

The People's Network is the product of a £100 million investment by the Big Lottery Fund which has linked all UK libraries to the Internet. A further £20 million was invested in ICT training for public library staff. Over 30,000 computers have been linked to the Internet in over 4,000 libraries.

As a result of the People's Network, libraries have helped thousands of adults and young people to become confident and competent in using ICT. Libraries are also providing a range of value-adding services such as portals to validated information resources in topic areas such as health and wellbeing, and are beginning to facilitate interactive learning environments.

Given the central role that ICT, digitisation, elearning and electronic knowledge management plays within the sector, it is felt that a Network is a useful concept to collate and disseminate information on and about ICT.

The aim of the Network is to reduce the distance between people with an interest in ICT. The Network will act as a communication tool to disseminate information about ICT issues affecting, and that has potential value and interest, to the sector. It will act as a focal point for sharing information on project issues, experiences of ICT products and partnership opportunities etc. It will therefore, be a link between the museum, library and archive sector and the wider ICT world.

MLA West Midlands will provide administrative support to the Network. **To join the Network all you have to do is submit your email address to MLA West Midlands.** Membership of the Network is open to any one within the museum, library and archive community in the West Midlands, as well as those in the ICT sector with an interest in supporting or developing products for and with the cultural institutions. Individuals or groups outside of the West Midlands with an interest in collections or activities in the region are also welcome to join.

During 2005 MLA West Midlands will produce an enewsletter 3 times per year. It will be based around the discussion of thematic topics, as well as highlighting details of completed, ongoing or emerging projects. It will also feature ICT developments internationally, a forum for questions and answers, debate, collaborative opportunities and training sessions.

Between e-newsletters MLA West Midlands will continue horizon-scanning and flag up relevant developments via e-alerts to the ICT Network discussion list. MLA West Midlands will also arrange two 'visionary visits' per year to significant projects where ICT has been used innovatively within service delivery or to ICT developers/suppliers. These will provide opportunities for Network members to discuss activities and issues in an informal setting. MLA West Midlands will also explore the possibility of arranging an ICT Research and Development event/exhibition, annually or biannually. They will invite developers, researchers, suppliers, consultants, digital artists etc to allow museums, libraries and archives in the sector to see and discuss ICT developments and applications.

#### Another Successful Year – Archives Awareness Campaign 2004

From introductions to researching Family History to the delights of allotments in Warwickshire and garden history in Herefordshire, record offices across the region have joined in the second national campaign to promote the value and potential of archives.

In Gaydon, the Wheels Around the World exhibition by the British Motor Industry Heritage Trust, picked up the National Routes to Roots theme to celebrate the spirit of expedition through objects, photographs and moving film detailing the impact of the motorcar on travel and adventure.

The combination of AAC 2004, the BBC Family History Series 'Who Do You Think You Are?' and the regional BBC road-shows on Family History over the weekend of 4-5 December has generated a vast amount of interest and opened people's eyes to the opportunities documentary heritage holds, whether something to be dipped into for fun or a source for detailed research.

During 2005, MLA West Midlands will look to work with the sector and holders of archives, whether record offices, museums or libraries to maximise the benefits AAC 2004 has brought. They will also continue to raise awareness of our archival heritage and the investment it needs.

#### A Two Tier Approach to launching Inspiring Learning for All (ILFA)

On 1 Nov 2004 MLA West Midlands held a higher management level launch to the Manager's Network. Seven sub-regional training days were run to introduce ILFA to senior managers and learning practitioners. These events reached 140 staff across the region.

The next phase of implementation, which will include strategic advocacy with Heads of Service and regional networks, is currently being planned. The ILFA framework includes Generic Learning Outcomes methodology for measuring the impact of museums, libraries and archives on learners. This is a significant step forward as it enables evidence to be produced in a format that demonstrates impact. The 10-15 museums, libraries and archives involved in the Pilot Scheme will be feeding back evidence of this methodology. The aim of the scheme will be to monitor and support these pilot organisations to enable us to gather case study materials about how ILFA is being implemented by different types of museums, libraries and archives.

#### Museum 'Renaissance' to be extended

Regional and local museums received a boost in December 2004 with the announcement of £17 million new funding for the Renaissance scheme, led by MLA. The announcement by DCMS will allow

MLA to extend the scheme across the country. Museums currently in the scheme have achieved astonishing results. In the first year visits by school children rose by 28% and museums have doubled their work with community groups, exhibitions and displays have improved, visitor numbers have soared, and some £7 million is being spent on improving collections.

## Online library seeks volunteers for the frontline

The first phase of the new People's Network Service was launched to professionals in December 2004. It will deliver a free real-time information service to the public by providing 'live' access to library and information professionals across the Internet.

Developed by MLA Council the service is being delivered collaboratively by public library staff across England. Currently 29 library authorities in England are piloting the service. MLA is now inviting library colleagues across the country to trial the new service by asking simple questions. MLA hopes that by the end of 2005 all 149 library authorities in England will contribute to the service.

#### What can a bursary of £300 do for Distance Learning studies?

## MSc Econ / Dip in Archives Administration (University of Wales, Aberystwth) through Distance Learning.

My name is Sarudzayi Chifamba-Barnes. I am 34 years old and work at the Coventry City Archives as an Archives Assistant. First of all I would like to thank MLA West Midlands for offering me a bursary of £300 for the above professional training course. The course itself takes between 2-5 years to complete, comprises of 10 modules with a total of 120 credits (postgraduate diploma) and 60 credits for the dissertation (Masters), with three compulsory study schools. The Society of Archivists accredits the qualification. The total fees for the whole course is about £4,800, but the University is flexible and allows one to pay by monthly instalments spread over 3 years.

I have worked in Archives and Museums since I left school in 1995. With lots of in-house training which I received in Zimbabwe, Oman (Middle East), Netherlands and here in Britain at the Coventry City Archives, I felt that it was high time I attained a professional qualification to augment my experience, and also to become a qualified archivist. That is why I enrolled with the University of Wales, Aberystwyth for the study course through distance learning.

Distance learning allows me to gain practical experience while studying at the same time, look after my family, and study in my own home and at my own pace. I do have to emphasise though that it requires a lot of discipline and proper management of time. Distance learning is flexible. There are 14 students in my group from all over the UK, including two other students from the West Midlands, i.e., Wolverhampton and Sandwell. At our first study school we got the chance to meet our tutors and other students and shared our experiences and knowledge about the profession. Distance learning knows no boundaries. There are lots of students from Germany, Switzerland, Republic of Ireland, Barbados, Jamaica and Trinidad at the school who were also studying for various qualifications in Archives, Library and Records Management. I was really impressed to see people from around the globe pursuing professional qualifications via distance learning.

The MSc Econ/Diploma Archives Administration course structure itself looks at all the professional issues related to archives, from the definition of an archive and record, to acquisition, preservation, historical manuscripts, access, legislation, funding, archives buildings etc. It is very comprehensive and gives confidence in one's job. As a mother of two, with my younger one being 3 years old, I do not have to leave my family to go and study in Wales. I hope to finish my course in 3 years.
